The ornamental design for a display screen with graphical user interface and icons, as shown and described.

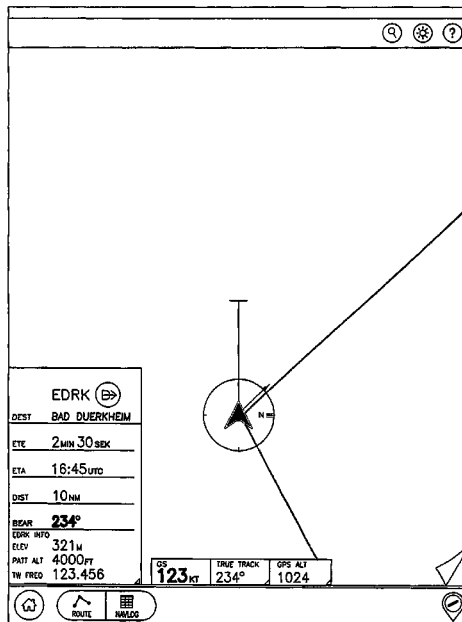
DESCRIPTION

FIG. 1 is a front view of a display screen with graphical user interface and icons, showing the first embodiment of the new design in a landscape mode; and,

FIG. 2 is a front view of a display screen with graphical user interface and icons, showing the second embodiment of the new design in a portrait mode.

The portion of the display screen is understood to be flush with the perimeter of the graphical user interface.

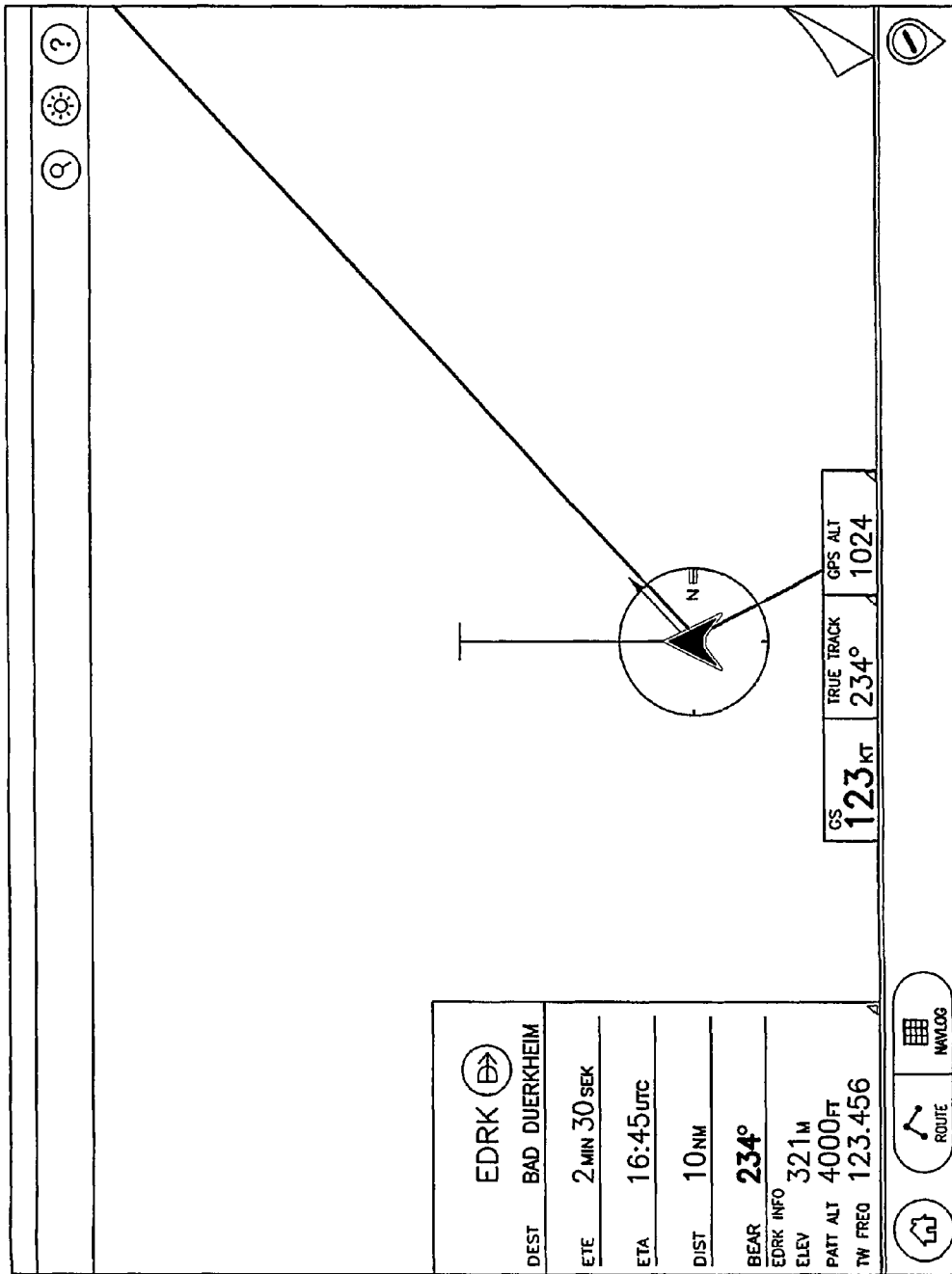

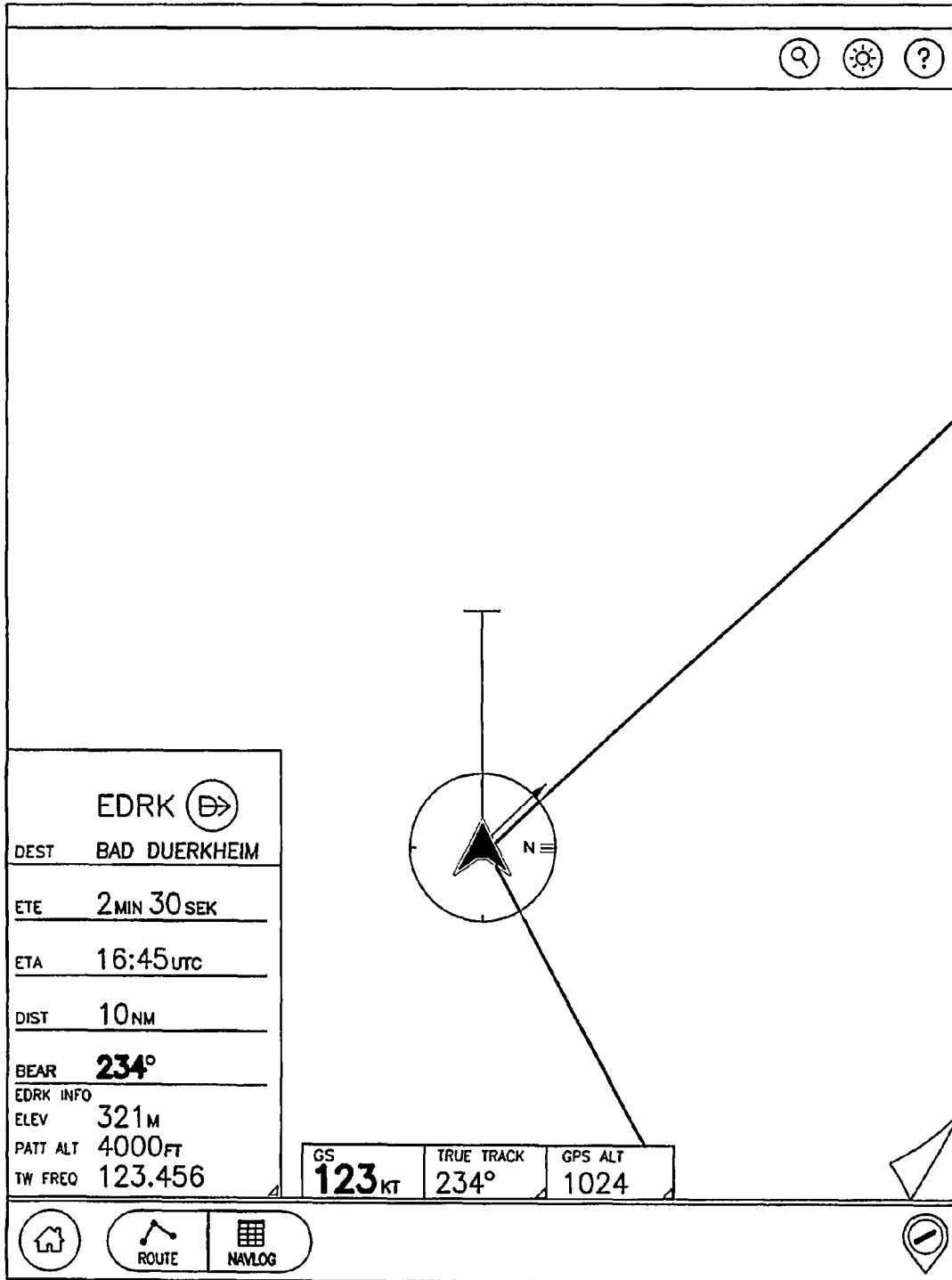
